Memorial permit charges to be paid at the time of interment		
Rights to erect a memorial for 25 years (refer to Cemetery Regulations) includes right for temporary marker cross for 2 years only.	250	250
Right to erect a plaque memorial for scattered remains (in place for 10 years only)	60	120

Undertakers/stone masons shall arrange the removal of all memorials (headstones, kerbs, etc) in consultation with the Clerk.

Construction of all bricked graves to be in consultation with the Clerk and will incur additional charges – price on application.

For any other services not shown above – price on application to the Clerk.

Non-residents charges apply where the person interred or was immediately before his/her death not an inhabitant or parishioner of the Parish of Sitlington or in the case of a still born child where neither of the parents is, or was at the time of the interment, such an inhabitant or parishioner. It was agreed by the Parish Council in July, 1996 (Minute 77), that the Clerk, with the agreement of the Chairman and Vice-Chairman, should have the

authority to waive the non-resident charges in cases where immediately before the death of a person, she/he has lived in a residential or nursing home outside the parish and immediately before entering the home they have lived for a considerable time in the parish.

Cemetery Charges: -

Photocopy of entry into burial register - £25

Search of Registers - £40 per enquiry.

Transfer of exclusive right of burial - £37

Declaration of lost certificate - £10

Exhumation charge – POA

Memorial Bench (wooden) - £1200 for 10 years to include purchase all maintenance
